Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 24, 2024, placed the rating(s) of Steel Case (SC) under the 'issuer non-cooperating' category as SC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 09, 2025, June 19, 2025, June 29, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Surat-based (Gujarat) SC was established in May, 1986 as a proprietorship firm. SC is established and primarily managed by Mr. Kamlesh Jaysukhlal Bhuta; Proprietor and his son Mr. Shubhendu Kamlesh Bhuta. SC mainly executes projects for manufacturing of laboratory furniture like laboratory tables, racks, chemical storage cabinets, fume hoods, gas piping systems as well as heating, ventilation and air conditioning (HVAC) systems with an installed capacity of 150 tonnes per annum as on March 31, 2018.
