Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 21, 2024, placed the rating(s) of S.G. Agro Industries (SAI) under the 'issuer non-cooperating' category as SAI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SAI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 07, 2025, July 17, 2025, July 27, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

S.G. Agro Industries (SAI) was established as proprietorship concern in 2012. However, the commercial operations of the firm commenced in April, 2013. The firm is currently being managed by Mrs. Tricha Goel as its proprietor along with the help of her husband, Mr. Gourav Goel. SGA is engaged in processing of paddy and milling of rice at its manufacturing facility located in Karnal, Haryana.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of SAI into ISSUER NOT COOPERATING category vide press release dated May 29, 2025 on account of its inability to carry out a review in the absence of requisite information.

Acuite has continued the rating assigned to the bank facilities of SAI into ISSUER NOT COOPERATING category vide press release dated November 21, 2024 on account of its inability to carry out a review in the absence of requisite information.
