Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 01, 2024, placed the rating(s) of M. C. Roller Flour Mills Private Limited (MCRFMPL) under the 'issuer non-cooperating' category as MCRFMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MCRFMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 17, 2025, June 27, 2025, July 07, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the company

Uttar Pradesh based M. C. Roller Flour Mill Pvt Ltd (MCR) was incorporated in 1987. The company is currently being managed by Mr Suresh Chand Singhal, Ms. Pushpa Singhal, Mr Amit Kumar Singhal and Mr. Rohit Kumar Singhal. The company is engaged in processing (milling) of wheat grains into flour, maida, semolina and choker. The manufacturing unit is located in Shahjahanpur, Uttar Pradesh. Furthermore, MCR is also engaged in trading of wheat grain, white flour and semolina.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of MCR into Issuer Not Cooperating category vide press release dated February 14, 2025 on account of its inability to carry out a review in the absence of requisite information.
