Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 16, 2024, placed the rating(s) of Dutta Agro Plantations Private Limited (DAPPL) under the 'issuer non-cooperating' category as DAPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DAPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 02, 2025, July 12, 2025 and July 22, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Dutta Agro Plantations Private Limited (DAPPL) was incorporated in 1998 by Mr. Sanjay Dutta. Earlier the company was into trading of tea leaves till October 2015. However, the company has set up its tea processing plant and started processing and sale of tea from November 2015 onwards. The processing plant of the company is located at Chaoaphali Basti, Jalpaiguri, West Bengal.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of DAPPL into Issuer Not Cooperating category vide press release dated August 27, 2024 on account of its inability to carry out a review in the absence of requisite information.
