Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 20, 2024, placed the rating(s) of Radiant Industries (RI) under the 'issuer non-cooperating' category as RI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 06, 2025, July 16, 2025, July 26, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Radiant Industries was established in the year 1995 as a partnership firm by Mr. Vijay Jadhav and Mrs. Sangeeta Jadhav. The entity is engaged in manufacturing of fabricated and precision machined metal components (viz wind mill parts, heavy engineering products and die holders, bolsters, tooling and others) which finds its major application in the automobile industry, forging and tooling, oil and gas industry and in the windmill sector.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of RI under Issuer Not Cooperating category vide press release dated June 13, 2025 on account of its inability to carry out a review in the absence of the requisite information from the firm.
