Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 16, 2024, placed the rating(s) of Unitech Fabricators & Engineers Private Limited (UFEPL) under the 'issuer non-cooperating' category as UFEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. UFEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 02, 2025, July 12, 2025 and July 22, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of UFEPL have been revised on account of non-availability of requisite information.
