Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 09, 2024, placed the rating(s) of Rutu Enterprises (RE) under the 'issuer non-cooperating' category as RE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 25, 2025, July 05, 2025 and July 15, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Rutu Enterprises was established in 2011 and undertakes turnkey project services & contracts in construction of roads, laying pipelines, civil and other construction works. Furthermore, the firm has also ventured into electrical contracts and has also undertaken railway contracts.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of RE into Issuer Not Cooperating category vide press release dated May 12, 2025 on account of its inability to carry out a review in the absence of requisite information.
