Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 15, 2024, placed the rating(s) of J.S.R & Company (JC) under the 'issuer non-cooperating' category as JC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 31, 2025, June 10, 2025, June 20, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The firm is a civil contractor and has its registered office located at Karimnagar, Telangana. JC is engaged in civil construction works such as laying of roads in the state of Telangana. The clientele of the firm includes various departments of Telangana Government such as Roads and Building Department, Panchayat Raj Department, etc.

Status of non-cooperation with previous CRA: CRISIL has moved the ratings assigned to the bank facilities of JC to the 'issuer not-cooperating' category vide press release dated August 08, 2025 on account of its inability to carryout review in the absence of requisite information from the firm.
