Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 15, 2024, placed the rating(s) of Srie Flora Garmments (SFG) under the 'issuer non-cooperating' category as SFG had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SFG continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 31, 2025, June 10, 2025, June 20, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Tirupur based, Srie Flora Garmments (SFG) was established in 2009 and promoted by Mr. Siva Kumar and Ms. Kalpana Devi. The firm is mainly engaged in the manufacturing and export of knitted and hosiery garments.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of SFG into Issuer Not Cooperating category vide press release dated March 13, 2025 on account of its inability to carry out a review in the absence of the requisite information from the firm.
