### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 09, 2024, placed the rating(s) of Joy Ma Lakshmi Cold Storage Private Limited (JMLCSPL) under the 'issuer non-cooperating' category as JMLCSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JMLCSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 25, 2025, July 05, 2025, July 15, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
