Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 27, 2024, placed the rating(s) of Soni Auto & Allied Industries Limited (SAAIL) under the 'issuer non-cooperating' category as SAAIL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SAAIL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 13, 2025, July 23, 2025 and August 02, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of SAAIL have been revised on account of non-availability of requisite information.

Soni Auto & Allied Industries Limited (SAAIL) was incorporated in the year 1984. In the year 1995, the company was acquired by the current promoter Mr. B.L. Jhunjhunwala. SAAIL manufactures all kinds of leaf Spring (Trailer Leaf Spring, Parabolic Leaf Spring and Helical Coil Springs) with installed capacity of 36,800 MTPA at its plant located in Jamshedpur. SAAIL products find application in Multi Utility Vehicles (MUV), Light Commercial Vehicles (LCV), Medium Commercial Vehicles (MCV), Heavy Commercial Vehicles (HCV) and Passenger Vehicles (PV).
