### **Rationale & Key Rating Drivers**

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 28, 2024, placed the rating(s) of Ekcon Infra projects (EIP) under the 'issuer non-cooperating' category as EIP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. EIP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 14, 2025, July 24, 2025, August 03, 2025 and August 20, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings have been revised on account of non-availability of requisite information. Further it also considers delay in debt servicing as recognized from publicly available information i.e., e-auction notice issued by the lender as well as CIBIL Filings.
