Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) has withdrawn ratings assigned to the Bank facilities and Non-Convertible Debentures (NCD) issue of Reliance Broadcast Network Limited (RBNL) with immediate effect, as entire debt of existing lenders has been cleared / repaid as ordered by the Hon'ble National Company Law Tribunal (NCLT), pronounced on May 06, 2024, under the Insolvency & Bankruptcy Code. The above action has been taken at the request of RBNL and 'No Dues Certificate' received from the lenders and Debenture Holders, that have extended the facilities/instruments rated by CareEdge Ratings.
