Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 31, 2024, placed the rating(s) of Megha Constructions (MC) under the 'issuer non-cooperating' category as MC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 16, 2025, June 26, 2025, July 06, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Hyderabad (Telangana) based, Megha Construction was established in the year 2013 as a partnership firm by Mr. Dinesh Gaba and Ms. Varsha Gaba. The firm is engaged in the civil construction work relating to buildings, parks, schools, colleges, complexes etc. The firm procures 70% of its orders directly through tenders and the balance 30 % of its work orders from 'Ambience Constructions India Limited. The firm has an order book to a tune of Rs. 49.97 crore and the same is likely to be completed by March 2020.
