Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 18, 2024, placed the rating(s) of Shree Nathji Cotton & Oil Industries (SNCOI) under the 'issuer non-cooperating' category as SNCOI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SNCOI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 04, 2025, August 14, 2025, August 24, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
