Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 17, 2024, placed the rating(s) of Surya Cotton Industries (SCI) under the 'issuer non-cooperating' category as SCI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SCI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 03, 2025, August 13, 2025, August 23, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Surya Cotton Industries (SCI) was established in October, 2011 as a partnership concern by five partners. SCI is engaged in cotton ginning and pressing. SCI is into the business of manufacturing of cotton bales, cotton seed cake and cotton seed oil with installed capacity of 1,500 Metric Tonnes Per Annum (MTPA), 2,800 MTPA and 336 MTPA respectively.
