CARE Ratings Limited (CareEdge Ratings) has withdrawn the rating assigned to the issuer rating of Bengal & Assam Company Limited (BACL) with immediate effect as requested by the company.

BACL is the holding company for the JK group headed by Bharat Hari Singhania as its Chairman. BACL was originally incorporated as Bengal & Assam Investors Limited in 1947. The company's name was changed to the present one in 1982. Registered as a Non-Deposit Taking Systematically Important Core Investment Company (CIC-ND-SI) with Reserve Bank of India (RBI), the company acts only as an investment holding company for the JK group companies and does not engage in lending to third parties outside the JK group. Being CIC-ND-SI, BACL is exempt from certain compliances of RBI like minimum requirement of net-owned funds and exposure norms. It has notable stake in group companies, such as JK Lakshmi Cement Limited (JKLC), JK Tyre & Industries Limited (JKTIL), JK Fenner (India) Limited (JKF), JK Agri Genetics Limited (JKAGL) and JK Paper Limited (JKPL).
