Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 14, 2024, placed the rating(s) of K.Radhakrishna Naik (KN) under the 'issuer non-cooperating' category as KN had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KN continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 30, 2025, July 10, 2025, July 20, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The firm is a class I civil contractor for Public Works Department (PWD), Karnataka for undertaking civil constructions of buildings, roads etc. Over the last two years, KRN has constructed roads and bridges in Bantwal and Mangalore regions of Karnataka for Karnataka Rural Road Development Agency (KRRDA) and Public Works Department, Karnataka. The firm subcontracts 30% of its labour work to various other contractors.
