Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 11, 2024, placed the rating(s) of Om Cottex (OC) under the 'issuer non-cooperating' category as OC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. OC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 28, 2025, August 07, 2025, August 17, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Botad (Gujarat) based Om Cottex (OC) was established in 2008 as a partnership firm. Currently, OC is managed by six partners with unequal profit and loss sharing agreement between them. OC is into the business of cotton ginning & pressing and crushing of cotton seeds. While cotton bales are used in manufacturing of cotton yarn, cotton seeds are further processed for extraction of edible oil. OC operates from its sole manufacturing facility located in Botad (Gujarat). OC markets its products in the states of Gujarat, Tamil Nadu and Maharashtra.
