Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 11, 2024, placed the rating(s) of Bhilai Engineering Works (BEW) under the 'issuer non-cooperating' category as BEW had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BEW continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 28, 2025, August 07, 2025, August 17, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the firm

BEW was established as a partnership entity in 1968 by Mr. Gurucharan Khurana. The entity undertakes fabrication, casting and forging for capital equipment required by steel plants. The entity has its facility at Bhilai. Mr. Gurucharan Khurana and his sons Mr. Arvinder Khurana and Mr. Jeetinder Khurana oversee the day-to-day operations of the entity.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of BEW into ISSUER NOT COOPERATING category vide press release dated August 14, 2025 on account of its inability to carry out a review in the absence of requisite information from the firm.
