# Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 12, 2024, placed the rating(s) of S K Mohapatra (SKM) under the 'issuer non-cooperating' category as SKM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SKM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 29, 2025, August 08, 2025, August 18, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### **About the firm**

Cuttack (Odisha) based S K Mohapatra (SKM) was constituted as partnership firm in April 2005 by the three partners namely Mr Susanta Kumar Mahapatra, Mrs. Kumari Mahapatra and Mrs. Anjana Kumari Mahapatra. The first partner has 50% share in the firm whereas the second and third partners have 25% share in the firm each. Since its inception, the firm has been engaged in design, engineering, supply, installation, commissioning and maintenance of electrical transformers. SKM participates in tenders and executes orders for Western Electricity Supply Company of Orissa Ltd., (WESCO), Odisha Power Transmission Corporation Ltd. (OPTCL); and Central Electricity Supply of Odisha (CESU) etc.
