Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 11, 2024, placed the rating(s) of Rudra Agrotech (RA) under the 'issuer non-cooperating' category as RA had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RA continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 28, 2025, August 07, 2025, August 17, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Chitod (Chhattisgarh) based Rudra Agrotech (RA) was established in November 2015(started commercial operation from April 2016) as a partnership firm by Mr. Dharmendra Kumar Jain, Mrs. Mamta Golechha and Mrs. Sushila Golechha. The firm is engaged in the processing, milling of non-basmati rice. RA milling unit was located at Balod, Chhattisgarh. RA primarily procures paddy from farmers & local agents located in Chhattisgarh and other neighboring states. The firm is also engaged in custom milling which constitutes of 7.29 % of TOI in FY18. Mr. Dharmendra Kumar Jain manages the day-to-day operations of the business along other two partners and with a team of expert professionals who are having a long experience in the similar line of business
