Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 30, 2024, placed the rating(s) of Narayan Industries (Chhattisgarh) (NI) under the 'issuer non-cooperating' category as NI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. NI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 16, 2025, July 26, 2025, August 05, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the firm

Chhattisgarh based Narayan Industries (NI) was established in 2007 as a proprietorship firm. The firm has installed a rice and pulse milling unit at Bhatapara in Chhattisgarh. NI sells finished rice, broken rice, rice bran and various types of pulses like Masoor Dal, Moong Dal, Urad Dal etc. The day -to-day affairs of the firm are looked after by Mr Mukesh Motwani (Proprietor) along with a team of experienced personnel.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of NI into ISSUER NOT COOPERATING category vide press release dated November 11, 2024 on account of its inability to carry out a review in the absence of requisite information from the firm.
