## Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 16, 2024, placed the rating(s) of Simora Tiles LLP (STL) under the 'issuer non-cooperating' category as STL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. STL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 02, 2025, July 12, 2025, July 22, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of STL have been revised on account of non-availability of requisite information.

### **About the LLP**

Morbi (Gujarat) based STL was established in December, 2016 as a limited liability partnership firm by nineteen promoters and handled by four partners to undertake a green field project for manufacturing of Vitrified Tiles ranging size from 400\*400 mm to 600\*600 mm. STL has completed greenfield project for setting-up a new plant in Morbi (Gujarat) with an installed capacity of 62,000 Metric Tonnes Per Annum (MTPA) of vitrified tiles with a project cost of Rs.36.50 crore via debt-equity mix of 1.93 times. STL commenced its operations from April, 2018 onwards, from its manufacturing facility located at Morbi, Gujarat. The firm purchases majority of raw materials locally while it sells its final products to various states pan-India via its own sales personnel and also exports to countries like Dubai, Oman, Yemen etc. through merchant exporters.

**Status of non-cooperation with previous CRA:** CRISIL has moved the ratings assigned to the bank facilities of STL to 'Issuer Not Cooperating' category vide press release dated January 22, 2025 on account of its inability to carry out a review in the absence of the requisite information from the LLP.
