Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 06, 2024, placed the rating(s) of Chaudhary Rice Mills (CRM) under the 'issuer non-cooperating' category as CRM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. CRM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 23, 2025, August 02, 2025 and August 12, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Chaudhary Rice Mills (CRM) was established in 1981 as a partnership firm and is currently being managed by Mr. Anil Kumar and Mrs. Vijeta Rani sharing profit and losses equally. The firm is engaged in processing of paddy at its manufacturing facility located in Fatehabad.
