Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 19, 2024, placed the rating(s) of Healthico Quality Products Private Limited (HQPPL) under the 'issuer non-cooperating' category as HQPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. HQPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 04, 2025, June 14, 2025, June 24, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Company

Indore-based (Madhya Pradesh), Healthico Quality Products Private Limited (Formerly known as Healthico Pharma Private Limited) (HQPPL) was incorporated in March, 2010 as a private limited company. The company is setting up a project for manufacturing of stainless-Steel scrubbers under the brand of 'Mazic' which will primarily be utilized for cleaning purpose in households. The activity will mainly include purchasing stainless steel wires from the local market of different sizes and then processing it into the stainless-steel scrubbers. The activity will also include packing and sealing of the scrubbers. HQPPL will operate through its sole manufacturing facility at Indore with an installed capacity of manufacturing 400 metric tons of stainless-steel scrubbers per month.
