### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 05, 2024, placed the rating(s) of AMAR BIO TECH PRIVATE LIMITED (ABTPL) under the 'issuer non-cooperating' category as ABTPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ABTPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 23, 2025, July 01, 2025, July 11, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

In the year 2007, ABTPL reconstituted into current nomenclature i.e Amar Bio-Tech Limited and it was promoted by Mr. Krishnaiah. B (Director), Ms. Thanu.P (Director) and others. The company is engaged in production & processing of agricultural products like Hybrid Cotton Seed. ABTL's unit is located at Khairtabad, Hyderabad District. The company has reputed client base located in various parts of India. The company has changed its name to Amar Bio Tech Private Limited since August 10, 2020.

**Status of non-cooperation with previous CRA:** Acuite has continued the ratings assigned to the bank facilities of ABTPL to the 'issuer not-cooperating' category vide press release dated April 15, 2025 on account of its inability to carryout review in the absence of requisite information from the company.
