Credit Update

Bajaj Finance Limited (BFL, rated 'CARE AAA; Stable/ CARE A1+'), vide email dated September 16, 2025, informed CARE Ratings Limited (CareEdge Ratings) that it paid interest amounting to ₹423,957,801.00 on the due date, August 18, 2025, for the ISIN INE296A08797. However, payment totaling ₹158,363.00 (net of TDS) to a debenture holder could not be remitted due to frozen bank account status of the investor in the absence of Darpan ID¹. Once the freeze on the investor bank account was lifted in September 2025, BFL transferred the full payment of ₹158,363.00 to the concerned investor's bank account.

CareEdge Ratings notes that: (1) BFL had sufficient liquidity on the payment date, August 18, 2025. (2) The payment failures were caused by factors beyond the company's control and not due to unwillingness or inability to meet obligations. (3) The unpaid amounts were transferred to a designated escrow account on August 18, 2025 (on the due date), in line with The Securities and Exchange Board of India's (SEBI's) circular dated November 18, 2024.
