Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 23, 2024, placed the rating(s) of Aditya Group (AG) under the 'issuer non-cooperating' category as AG had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AG continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 08, 2025, June 18, 2025, June 28, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the firm

M/s Aditya Group (AG) was established in Guwahati as a partnership firm engaged in providing poultry hatching services in August, 2009 by Dr Ajit Kr Bhagowati, a Phd in Fisheries, and his daughter Ms. Lopamudra Bhagowati, who holds a B.Tech degree. The firm is engaged in production and selling of Day Old Broiler Chicks (DOC). The main raw material for production of DOC is 'Hatching Eggs' (HE) with an installed capacity of producing 4,20,000 hatchlings per month. In April 2018, the firm started its own chicks breeding farm at Bangalore which are transported to Guwahati where hatching of eggs is done. The overall functioning of Aditya Group is looked after by Ms. Lopamudra Bhagowati & Mr Kinjalak Bhagowati. Apart from Aditya Group, there are two group companies: North East Poultry House Pvt Ltd., involved in trading of poultry feed and Poly Poultry Agro Pvt Ltd., involved in broiler feed and contract growing farm.
