### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 06, 2024, placed the rating(s) of Akash Ganga Rice Mills Private Limited (AGRMPL) under the 'issuer non-cooperating' category as AGRMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AGRMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 23, 2025, August 02, 2025, August 12, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of AGRMPL have been revised on account of non-availability of requisite information.

The milling and processing plant of the company is located at Burdwan, West Bengal with capacity of 480 metric ton per day (MPD). The company procures its raw material i.e. paddy from farmers & local agents and sells its finished products through the wholesalers and distributors across West Bengal, Jharkhand & Bihar.
