Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 03, 2024, placed the rating(s) of Millenium Steel India Private Limited (MSIPL) under the 'issuer non-cooperating' category as MSIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MSIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 20, 2025, July 30, 2025, August 09, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Company

Millenium Steel India Private Limited (MSIPL) incorporated on February 9, 2005, is promoted by Mr D. Hari Prasad Reddy. The company is engaged in trading of Thermo Mechanical Treatment (TMT) bars and other steel products, Steam coal and cement bags. Initially, the company started with trading of iron and steel products. MSIPL mainly trades from their five trading offices situated in Chennai, Kochi, Nellore, Bengaluru and Muthyalapadu. The day to day operations of the company are managed by Mr Hari Prasad Reddy and his wife Mrs Jyothi.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of MSIPL into Issuer Not Cooperating category vide press release dated July 16, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.

Infomerics has continued the rating assigned to the bank facilities of MSIPL into Issuer Not Cooperating category vide press release dated October 29, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
