### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 08, 2024, placed the rating(s) of Dindayal Industries Limited (DIL) under the 'issuer non-cooperating' category as DIL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DIL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 24, 2025, September 03, 2025, September 13, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Gwalior (Madhya Pradesh) based Dindayal Industries Limited (DIL) was initially incorporated as Dindayal Aushadhi Private Limited by Chhapparwal in 1992. DIL is engaged in the business of manufacturing and trading of Ayurvedic Vitalizers. The company is located in Gwalior, Madhya Pradesh.
