CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 10, 2024, placed the rating(s) of Infertility Institute And Research Centre Private Limited (IIRCPL) under the 'issuer non-cooperating' category as IIRCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. IIRCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 27, 2025, August 06, 2025, August 16, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
