### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 13, 2024, placed the rating(s) of Skilled Construction Company Limited (SCCL) under the 'issuer non-cooperating' category as SCCL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SCCL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 30, 2025, August 09, 2025, August 19, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Incorporated in 1991, as a private limited company, Skilled Construction Company Limited (SCCL, was later reconstituted into a public limited company in the year 1997) is a Class A contractor registered with Kerala State Public Works Department and is engaged in the construction of bridges, flyovers, railway over bridge and others miscellaneous work. The company since inception has been engaged primarily in building of road over bridges (ROB) and has completed around 27 projects. SC C's major clients Brief Financials (Rs. crore) include Roads & Bridges Development Corporation (RBDC) of Kerala and Southern Railways; it also receives contracts from M/s KITCO Ltd, National Highway Authority and others.
