### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 11, 2024, placed the rating(s) of Adi Tradelink (AT) under the 'issuer non-cooperating' category as AT had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AT continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 28, 2025, August 07, 2025, August 17, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

**Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).**

The ratings assigned to the bank facilities of AT have been revised on account of non-availability of requisite information.

**Analytical approach:** Standalone; Revised from Combined; CARE Ratings has considered the combined operational and financial performance of Adi Tradelink (AT) and Adi Enterprises (AE) since both these entities are engaged in similar line of business and operate under common management. However, updated information is not available to ascertain financial linkages that warrant a continuation of combined approach.
