Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 04, 2024, placed the rating(s) of Vasupati Agro Product Private Limited (VAPPL) under the 'issuer non-cooperating' category as VAPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VAPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 21, 2025, July 31, 2025, August 10, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Vasupati Agro Product Private Limited was incorporated in June 2013 with an objective to enter into the rice milling and processing business. The company has started its operation from April 2016. The company is procuring raw materials from the local farmers. The registered office of the company is located at Vill-Moyna, P.O- Nabagram, P.S- Jamalpur, Dist- Burdwan. Status of non-cooperation with previous CRA: ICRA has continued the rating assigned to the bank facilities of VAPPL into Issuer Not Cooperating category vide press release dated January 31, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.
