### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 19, 2024, placed the rating(s) of Jai Mata Di Food Processing Private Limited (JMDFPPL) under the 'issuer non-cooperating' category as JMDFPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JMDFPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 05, 2025, August 15, 2025, August 25, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the company

Jai Mata Di Food Processing Pvt. Ltd. (JMDFPPL) was incorporated in November, 2014 by Mr. Sanjay Kumar, Mrs. Sabita Devi and Mrs. Ruma Devi of Patna, Bihar. The company is engaged in processing and milling of rice. The rice milling unit of JMDFPPL is located at Bihta, Patna with processing capacity of 22,810 metric tonne per annum (MTPA), which is in the vicinity to a major rice growing area. The company has started commercial operations from January, 2017 onwards. Mr Sanjay Kumar (aged, 45 years), having around decade long experience in the rice milling industry, looks after the day to day operations of the company. He is supported by other directors Mrs Sabita Devi (aged, 42 years) and Mrs Ruma Devi (aged, 37 years) and a team of experienced professionals.
