Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 27, 2024, placed the rating(s) of KGP Gold & Diamond (KGD) under the 'issuer non-cooperating' category as KGD had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KGD continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 13, 2025, August 23, 2025, September 02, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Gold and Diamond (KGD) is a proprietorship concern established in 2018 by Mr Ganesh D Shet and is involved in the retail trade of gold, diamond and other precious stones jewellery. The firm also has two associate concerns – K.G. P Gold Palace (reaffirmed CARE B-; Stable on February 24, 2020) and K.G.P. Jewellers (reaffirmed CARE B-; Stable on February 24, 2020) which are also involved in the similar line of business. The firm intends to procure its raw materials from local market and outsources its manufacturing activities on job work basis to manufacturers in local markets.
