### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 19, 2024, placed the rating(s) of Bahubali Cashews (BC) under the 'issuer non-cooperating' category as BC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 05, 2025, August 15, 2025, August 25, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Udupi (Karnataka) based Bahubali Cashews (BC) is a proprietorship firm established by Ms. Nirmala Mahaveer Hegde in 1987. The promoter has an experience of over a decade similar line of business. BC is into Processing and trading of raw cashew nuts. The firm procures its raw material, the raw nuts, from Indonesia, Benin, Tanzania and other African countries, around 60% of the import is from African countries. BC Sells the pro cessed cashews nuts in to domestic market only. Presently, the day to day operations are managed by Mr. Mahaveer Hagde.

### Status of non-cooperation with previous CRA:

CRISIL has continued the ratings assigned to the bank facilities of BC to the 'issuer not-cooperating' category vide press release dated May 29, 2025 on account of its inability to carryout review in the absence of requisite information from the firm.
