Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 08, 2024, placed the rating(s) of Vintage Home Fashions (VHF) under the 'issuer non-cooperating' category as VHF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VHF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 24, 2025, September 03, 2025, September 13, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

VHF was established in April 1999 as a proprietorship firm by Mr Puneet Chugh. The firm is engaged in the manufacturing of textile home furnishing products which includes bed sheets, curtains, quilts, blankets, carpets, etc, at its manufacturing unit located in Panipat, Haryana.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of VHF into Issuer Not Cooperating category vide press release dated May 23, 2025 on account of its inability to carry out a review in the absence of requisite information.
