Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 05, 2024, placed the rating(s) of Srinivas Agro Processors (SAP) under the 'issuer non-cooperating' category as SAP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SAP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 22, 2025, August 01, 2025, August 11, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Firm

Srinivas Agro Processors (SAP) was established in the year 2013 as a partnership firm by Mr. R. Vivekananda Shenoy and Mr. G. Dileep. The firm is engaged in processing of raw cashew nuts into cashew kernels and the manufacturing unit has an installed capacity to process 80 bags per day at Karkala, Karnataka. The process involves steam roasting, shell cutting, drying, sorting, peeling and grading. The firm majorly procures raw material (raw cashew nuts) from African countries like Benin, Togo, Ivory Coast, Burkina Faso, Tanzania, Indonesia etc. The firm imports raw cashew nuts (around 95%) owing to better quality and relatively lower prices as compared to the domestic market and also purchases locally from the farmers located in Karnataka (Around 5%). The firm sells the cashew kernels to wholesalers located all over India majorly in the states Karnataka, Andhra Pradesh, Maharashtra, Rajasthan and Delhi among others. The firm also generates income from sale of by-products like cashew shells, cashew husk and rejections.
