Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 25, 2024, placed the rating(s) of Shreeya Peanuts Private Limited (SPPL) under the 'issuer non-cooperating' category as SPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 11, 2025, August 21, 2025, August 31, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the company

Incorporated in October 2013, Shreeya Peanuts Private Limited (SPPL) is engaged in groundnut oil milling, solvent extraction and refinery of edible oil with an installed capacity for the oil mill plant is 22,000 MTPA, 44,000 MTPA for the solvent plant and 22,000 MTPA for the refinery plant.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of SPPL to 'Issuer Not Cooperating' category vide press release dated May 19, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.

Brickwork has continued the ratings assigned to the bank facilities of SPPL to 'Issuer Not Cooperating' category vide press release dated December 23, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
