### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 03, 2024, placed the rating(s) of AL-Ameen Charitable Fund Trust (ACFT) under the 'issuer non-cooperating' category as ACFT had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ACFT continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 20, 2025, July 30, 2025, August 09, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of ACFT have been revised on account of non-availability of requisite information.
