Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 27, 2024, placed the rating(s) of ShyamShree Residency Private Limited (SRPL) under the 'issuer non-cooperating' category as SRPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SRPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 13, 2025, August 23, 2025, September 02, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Bhubaneswar (Orissa) based Shyamshree Residency Private Limited (SRPL) was incorporated in 2006 by Mr. Saket Agarwal along with his family members. The company is engaged in the business of erection and commissioning of transmission and distribution of electrical lines for government departments such as Madhya Pradesh Poorv Kshetra Vidyut Vitaran Company Limited (MPPKVCL) and also manufactures PCC poles. It is registered A class contractor with MPPKVCL.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of SRPL to 'Issuer Not Cooperating' category vide press release dated January 06, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.
