### Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 07, 2024, placed the rating(s) of Godhani Impex (GI) under the 'issuer non-cooperating' category as GI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 23, 2025, September 02, 2025, September 12, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Godhani Impex (GI) was established on March 11, 2005 as a partnership firm by three brothers from the Odhavjibhai Godhani family. The partners of GI were earlier partners in M/s Godhani Gems (subsequently reconstituted to Godhani Gems Pvt Ltd; which was managed jointly by Shri Virjibhai Godhani and Shri Odhavjibhai Godhani. Due to certain differences, Shri Odhavjibhai Godhani left GG and formed GI. All partners at GI have experience in the Gems and Jewellery business for over a period of 27 years. The firm is engaged into cutting and polishing of rough diamonds at its Surat workshop and exports the polished diamonds.
