Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 24, 2024, placed the rating(s) of Mahak Rice Industries (MRI) under the 'issuer non-cooperating' category as MRI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MRI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 10, 2025, August 20, 2025, August 30, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the firm

Mahak Rice Industries (MRI) was established as a proprietorship firm by Mr. Vikram Sadhwani in 2012 for setting up a rice milling unit. Since its inception, the firm has been engaged in rice milling and processing business and the plant of the firm is located in the district of Raipur, Chhattisgarh with aggregate installed capacity of 19,200 metric ton per annum.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of MRI into Issuer Not Cooperating category vide press release dated July 14, 2025 on account of its inability to carry out a review in the absence of the requisite information from the firm.
