### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 25, 2024, placed the rating(s) of Galaxy Life Care Services Private Limited (GLCSPL) under the 'issuer non-cooperating' category as GLCSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GLCSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 11, 2025, August 21, 2025, August 31, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

### About the company

The entity was incorporated in August, 2000 as a private limited company by the name of Sanjeevan Medical Research Centre and Hospital (Varanasi) Private Limited (SMRCHPL). Eventually, the name was changed to Galaxy Life Care Services Private Limited (GLCSPL) in November, 2013. The commercial operations commenced in April, 2004. The company operates a multispecialty hospital having various departments for urology, neurology, radiology, gynecology, nephrology, plastic burn & cosmetic surgery, endocrine and breast surgery, orthopedics, dental, physiotherapy, neurosurgery, cardiothoracic surgery, etc. along with 24 hours pharmacy and lab services and is located in Varanasi (Uttar Pradesh).

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of GLCSPL into Issuer Not Cooperating category vide press release dated February 14, 2025 on account of its inability to carry out a review in the absence of requisite information.
