### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 23, 2024, placed the rating(s) of Svasca Industries (India) Limited (SIL) under the 'issuer non-cooperating' category as SIL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SIL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 09, 2025, August 19, 2025 and August 29, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the company

Delhi based Svasca Industries (India) Limited (SIL) was incorporated in May, 1997 and is currently managed by Mr. Siddharth Tayal, Mrs. Tripti Tayal & Mr. Aditya Tayal. The company is engaged in the manufacturing, repair & maintenance of power & distribution transformers and servo voltage stabilizer.

**Status of non-cooperation with previous CRA:** Infomerics has continued the rating assigned to the bank facilities of SIL into Issuer Not Cooperating category vide press release dated June 27, 2025 on account of its inability to carry out a review in the absence of requisite information.

India Ratings has continued the rating assigned to the bank facilities of SIL into Issuer Not Cooperating category vide press release dated August 21, 2025 on account of its inability to carry out a review in the absence of requisite information.
