### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 25, 2024, placed the rating(s) of Three Sixty Textiles Private Limited (TSTPL) under the 'issuer non-cooperating' category as TSTPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. TSTPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 11, 2025, August 21, 2025, August 31, 2025, October 30, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

**Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).**

The ratings assigned to the bank facilities of TSTPL have been revised on account of non-availability of requisite information. The revision further considers the delays in debt servicing as recognized from lender's feedback as well as CIBIL fillings.

### About the Company

"Three Sixty Business Process India Private Limited" was established in the year 2007 and promoted by Mr. Kasi V Thiagarajan and Mr. T. Nagappan as first directors of the company. During May 2012, the company name has changed to current nomenclature "Three Sixty Textiles Private Limited" (TSTPL). Later in the year 2013, the company was taken over by Mr. S Sethuramasamy, Mr. S. Parimalam, Mr. A. Selvakumar along with their friends and family members. Company's registered office and factory are located in Thanneerpanthal, Coimbatore and is engaged in trading of cotton yarn and cloth. The company has availed moratorium from March to August 2020 amid COVID-19 RBI guidelines.
