Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 04, 2024, placed the rating(s) of Radhe Cotton Company (RCC) under the 'issuer non-cooperating' category as RCC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RCC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 21, 2025, July 31, 2025, August 10, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Firm

Gokhalana, Jasdan (Rajkot) – based RCC was incorporated as a partnership firm in 2012 by six partners. The partners of RCC include mainly Mr Rameshbhai Khakhriya, Manubhai Khakhriya and Dhirajbhai Jivabhai Khakhriya. The firm is engaged into the activity of cotton ginning, bailing and cleaning of cotton. The products of RCC include cotton seeds, cottonseeds oil cake and cotton wash oil.

Status of non-cooperation with previous CRA: Brickwork has continued the ratings assigned to the bank facilities of RCC in the 'issuer not-cooperating' category vide press release dated May 14, 2025 on account of its inability to carryout review in the absence of requisite information from the firm.
